1 During the period of 16-19 February 2009, 3GPP2 TSG-S meetings were held at the Sheraton Shanghai
2 Hotel & Residences Pudong in Shanghai, China. This document is intended to summarize those

4 **OPENING PLENARY**

7 Monday 16 February 2009 at 1:33PM local time by TSG-S Chair, Nick Yamasaki (KDDI).

8 The Chair welcomed everyone to Shanghai.

9 The meeting participants were requested to sign-in electronically using the server sign-in facility.
