During the Authentication Focus Group it was mentioned that the AHAG has agreed to review the material liaised from TSG-N last month and will respond when it has completed it's study.

The IP Core Network Focus Group agreed to meet via conference call rather than face to face at this meeting due to the number of contributions presented Tuesday.
