Opening Plenary:

Prepared a response to the TSG-Coordination ad hoc. Main concern was the reliance on coercion rather than cooperation in establishing the specification development process. Clarification was requested on additional items.

Discussed liaison from CDG on IOTA Stage 3. Several concerns were raised and a small group was formed to prepare a response to the CDG.

Correspondence from the TSG-S All IP ad hoc was missing attachments, Cathy Fitzpatrick was requested to obtain these for discussion at the closing plenary.

TTC requested publication of N.S0017-A based on TSG29-D. This was agreed upon and will sent to the secretariat for SC 15-day review.

WG1:

Stage 1 for 1-way roaming was introduced and discussed. After several modifications were recommended and a general approach was agreed to, the contributors were asked to revise and resubmit.

WG2:

Significant discussion on OSA from contributions. One contribution modifying the NAM text on Service Applications and the Multimedia Domain Service Control view was accepted. A contribution proposing inclusion of a proxy SCM in the NAM was accepted. These contributions were accepted as baseline text into the All IP Multimedia Domain document (N.0024).

Text for the All IP Legacy MS Domain document (N.0023) was approved as baseline.

Many contributions on Location Services were discussed.

WG3:

V&V completed on N.0029, TIA/EIA-41-E parts 000 and 5xx. An editorial review will be held in April.

V&V completed on N.0009, CDMA Packet Data Services. An editorial review will be held in April.

Closing Plenary:

The attachments to correspondence from the all IP ad hoc were reviewed. In response, a letter was written confirming TSG-N's support for retaining TSG-P as primary for interface 33.

Correspondence to the all IP ad hoc regarding modifications accepted to the NAM and included in N.0023 and N.0024 was approved. This will be copied to all TSGs to facilitate early adoption of the new text.

N.S0025 Roamer Database Verification was approved to be sent to the 3GPP2 secretariat for the SC 15 day review.

Correspondence from the all IP ad hoc requesting input on the workplan was reviewed. Members were requested to bring comments to the April meeting.
