Opening Plenary:

Correspondence to the All IP Ad Hoc regarding the draft All IP Workplan was approved. Significant questions had to do with the inclusion of interoperability between the Legacy MS domain and legacy systems, specifically roaming and handoff. This did not appear to be included in the workplan. The workplan did include a substantial section on legacy services which was surprising since this is already covered in TIA/EIA-41. This will be sent to the Ad Hoc for their discussions this week.

Correspondence to TSG-S regarding the Services Capability Guide was approved, pending the inclusion of identifiers for TTA and TTC documents. This will be finalized at the closing. Per a recommendation to include DMH in the set of 3GPP2 capabilities, TIA/EIA-124 will be distributed in 3GPP2 as N.S0026.

Correspondence to TSG-S regarding the draft response to ITU-T was approved, pending the inclusion of identifiers for TTA and TTC documents. This will be finalized at the closing.

While reviewing correspondence from TSG-S in response to issues raised by TSG-N, C. Fitzpatrick was requested, in her role as TSG-S liaison, to question the JEDI meeting scheduling procedures. It was noted that to achieve focused, quality participation, these meetings should not be held in the evenings during the TSG meetings. The use of conference calls, email, and even off-line meetings was recommended.

Correspondence to the All IP Ad Hoc containing the accepted modifications to the NAM was approved. This correspondence requests the Ad Hoc to integrate the changes into the NAM under their editorship.

While reviewing correspondence from TSG-S regarding the definition of a 3GPP2 vision statement, C. Fitzpatrick was requested, in her role as TSG-S liaison to request clarification of the purpose of the vision statement.

WG2:

Agreed in concept to bring in All IP call flows based on 3GPP's 23.228, but converted to correspond to the 3GPP2 NAM. A small group will meet via conference call to kick this off for the next meeting.

Significant discussion on Location Services, E-911, ESA, and CDMA/GSM roaming.

WG3:

Final editorial review on the first parts N.0029 to be held April 27.

Final editorial review on N.009 to be held at the May meeting in Seattle.

WG4:

Agreement was reached to adopt TIA/EIA-124-C as a 3GPP2 document. This is now out for SC 15 day review as N.S0026.

WG6:

N.0031 was approved for SC 15 day review pending editorial review. This should be complete by next week. This will go to the SC as N.S0027.

Closing Plenary:

2002 schedule modified to take advantage of hotel rate benefits by co-locating with TSG-C for back-to-back meetings. June meeting is now in Portland ME. October meeting is now in Seattle WA. December meeting is now in Maui.

Correspondence to TSG-S from the Opening Plenary was approved.

The TSG-N Document Matrix was updated to show the mapping from TSG-N documents to TIA, TTC, TTA, and CWTS documents.
