If the 3GPP2 meetings can be accommodated by the hotel, then there is an additional conflict with the currently scheduled TR-45 meeting. The TR-45 Chair requests that if 3GPP2 changes meeting dates, TR-45 be notified immediately in order to allow discussion during their May meeting.
