7b. A.S0022-0 v2.0 (IOS eHRPD-E-UTRAN) Revised Publication Text

Contribution A00-20100426-029R1 represents the revised publication text for A.S0022-0 v2.0. This text was previously remanded back to TSG-A following a 15-Day Steering Committee review in order to address some V&V editorial comments that were not corrected prior to the initial approval for publication back in Denver. The revised PDF file found in A00-20100426-029DR1 was approved for direct publication, following a motion by David Ott of Qualcomm and a second by Mike Dolan of Alcatel-Lucent. TSG-A also confirms that the only changes made to the document were to address the V&V comments that were not included in the initial publication draft.
