1 During the period of 15-19 April 2002, 3GPP2 TSG-C meetings were held at the Holiday Inn Historic
2 District in Alexandria, VA. This document is intended to summarize those proceedings.

4 OPENING PLENARY

5 1. CALL TO ORDER AND OPENING REMARKS: The meeting was called to order at
6 10:00 AM local time on 15 April 2002 by TSG-C Chair, Jean Alphonse (Lucent).

7 The Chair stated that the objectives for this week included resolution of all SDO comments for
8 publication of cdma2000 Release B.

9 2. ATTENDANCE REGISTRATION AND ROLL CALL: A roll call of companies indicated
10 that 26 companies included on the list of 35 active members were present and thus quorum was
11 established (74% participation).

12 3. INTRODUCTION AND NUMBERING OF CONTRIBUTIONS: Contributions were
13 loaded onto the 3GPP2 network server and listed in the document register (C00-20020415-
14 000).

15 4. AGENDA APPROVAL: The proposed agenda (C00-20020415-001) was presented.
16 **DECISION: This agenda was approved without objection as submitted.**

17 5. ASSIGNMENTS OF CONTRIBUTIONS TO AGENDA ITEMS: Contributions were
18 assigned to agenda items as noted on the agenda.

19 6. APPROVAL OF PREVIOUS MEETING SUMMARY: The meeting summary of the
20 March 2002 meeting in Kobe, Japan (C00-20020415-002) was presented. **DECISION:**
21 **This meeting summary was approved without objection as submitted pending the**
22 **incorporation of the contribution log from SWG2.3 (C00-20020415-002R1)**

23 The meeting summary of the 28 March 2002 interim Plenary conference call (C00-20020415-
24 003) was presented. The discussion noted that the contribution was incomplete as loaded onto
25 the server so action was deferred until closing Plenary.

- 26 • Correspondence related to the 3GPP/3GPP2 IP Core Network Harmonization
27 Workshop that was held during the period of 3-4 April 2002 (C00-20020415-029)
28 was presented. The correspondence from the 3GPP2 Secretariat indicated the
29 direction of the 3GPP2 SC Chair that the TSG review and comment on the workshop
30 output by 29 April 2002. **ACTION: This contribution was remanded to WG1,**
31 **WG2, and WG3 for review and response by the closing Plenary of this meeting.**
32 **WG1 was also directed to correlate the inputs from the other WGs for this**
33 **response.**
- 34 • E-mail correspondence disseminating the newly mandated 3GPP2 contribution cover
35 sheet (C00-20020415-030) was presented from the 3GPP2 Secretariat. This
36 contribution noted that the attached cover sheet must be used on all contributions and
37 that contributions received after 1 June 2002 without this cover sheet will not be
38 accepted. **ACTION: This contribution was remanded to all WGs as FYI.**

- 1 • Contributions related to the 3GPP2 SC and OP meetings that were held during the
2 period of 18-19 March 2002 in Maui, HI (C00-20020415-020) was presented.
3 TSG-C action items were discussed as follows:
- 4 • TSG-C was directed to proceed with cdma2000 Release A Addendum 3 in
5 case the CDG is unsuccessful in approving a work around solution. Action was
6 deferred on this item pending completion of the CDG meeting on this topic on
7 this evening. **DECISION: An interim Plenary was schedule for**
8 **Wednesday 17 April 2002 at 1:00 PM to discuss a TSG-C action plan**
9 **once the results of the CDG meeting are known.**
 - 10 • TSG-C was directed to provide a projection of how many harmonization
11 meetings should be projected for year 2003 and how these meetings will be
12 financed. The WG3 Chair, Ed Tiedemann (QUALCOMM), gave a brief
13 summary of the 3GPP/3GPP2 Spatial Channel discussions that were held in
14 Paris during the period of 9-10 April 2002 and noted that the meeting summary
15 was included in the WG3 contributions. As it relates to meeting requirements:
 - 16 • 3GPP2 will need to host a second Spatial Channel working meeting in
17 June 2002 for 2 days for approximately 20 persons.
 - 18 • 3GPP will host a one (1) day harmonization process planning session in
19 Italy on 28 June 2002.
 - 20 • 3GPP will also host a third Spatial Channel working meeting in August
21 2002 in Seattle, WA
 - 22 • The Spatial Channel effort is expected to last approximately six (6)
23 months but additional harmonization efforts are expected next year.
24 However, the level of effort and meeting requirements are currently
25 unknown.

26 **ACTION: The proposed 3GPP2 2003 calendar (C00-20020415-020D) was**
27 **remanded to all WGs for review and comment, especially on whether TSG-C**
28 **should have 11 or 12 meetings during the year.**

24 Coordinator from the 3GPP2 workplan, was presented. **ACTION: This**

4 **ACTION: These contributions were remanded to WG1 to enlist the support of**
5 **SWG1.1 in facilitating the development of associated requirements in TSG-S.**

- 6 • A contribution regarding a 1xEV-DO work item request (C00-20020415-031) was
7 presented by Lucent. **ACTION: This contribution was remanded to WG1 for**
8 **review and action as appropriate.**
- 9 • A contribution regarding a 1xEV-DV work item request (C00-20020415-032) was
10 presented by Lucent. **ACTION: This contribution was remanded to WG1 and**
11 **WG3 for review and action as appropriate.**

12 This session was recessed on 15 April 2002 at 12:20 AM local time.

14 INTERIM PLENARY

15 The meeting was reconvened on 17 April 2002 at 1:15 PM local time.

16 Quorum had been established at the opening Plenary and was not challenged. Five (5) additional
17 member company was noted in attendance.

18 6. APPROVAL OF PREVIOUS MEETING SUMMARY (continued):

8 10. OLD BUSINESS (continued):

- 9 • The following discussions were held regarding the directive from the SC to prepare a
10 new point release for cdma2000 Release A based on inclusion of a resolution to the
11 Sync Channel issue:
 - 12 • The CDG, Sam Samra (CDG), noted that they still had not reached any
13 resolution on the Sync Channel issue and that no decision should be expected
14 during the remainder of this meeting.
 - 15 • A concern was raised regarding whether any decision on Sync Channel
16 direction could be determined at this meeting based on the fact that neither the
17 Sync Channel nor cdma2000 Release A were included in the agenda. The
18 3GPP2 Secretariat ruled that this issue had been raised via processing of normal
19 correspondence related to the recent SC meeting and the action on cdma2000
20 Release A had been explicitly directed by the parent body of the TSG (i.e., the
21 SC). Therefore, action on this issue was indeed appropriate.
 - 22 • The Chair asked if there were any objections to TSG-C compliance with SC
23 ACTION 2002/03-01 (Agenda item 10.1 - Sync Channel Ad Hoc Report).
 - 24 • LGE objected to completing the action at this time.
 - 25 • Lucent objected to completing the action at any time.
 - 26 • Samsung objected to completing the action at this time.
 - 27 • **DECISION: After consultation with the 3GPP2 Secretariat, the Chair**
28 **directed the TSG as follows:**
 - 29 • **Since the SC Chair is responsible for the overall management of**
30 **the coordination work within 3GPP2, remanded actions from the**
31 **SC cannot be ignored. These remands must, however, be**
32 **managed within the context of the other items on the TSGs**
33 **workplan and, in cases of conflict, the SC can be requested to**
34 **reconsider its remand. The only responses to SC remands**
35 **allowable are:**
 - 36 • **The TSG will comply.**
 - 37 • **The TSG cannot comply with the letter of the remand**
38 **based on other responsibilities but will comply to our best**
39 **ability.**
 - 40 • **The TSG cannot comply with the remand at all based on**
41 **other responsibilities.**

- 1 • **Based on the WG2 Chair concerns regarding the Release B**
2 **schedule, the Chair directed that WG2 prepare the new point**
3 **release of cdma2000 Release A, as specified in the SC remand,**
4 **by the closing Plenary of the May 2002 meeting (17 May 2002).**
5 **However, such action need be completed only if a standards**
6 **based solution is warranted, based on the Sync Channel AdHoc**
7 **report to be received by the opening Plenary of that meeting**
8 **(13 May 2002).**
- 9 • **If a standards based solution is warranted, based on the Sync**
10 **Channel AdHoc report by the opening Plenary of that meeting**
11 **(13 May 2002), the revised Release A text will be released for**
12 **SDO review and comment at the closing Plenary (17 May 2002).**
- 13 • **WG2 and WG3 were also remanded the task of updating the**
14 **cover page of all of the other Release A volumes that are not**
15 **affected by the Sync Channel fix for approval at that closing**
16 **Plenary so that the point release/version numbers can be**
17 **synchronized.**
- 18 • **The Secretary was also directed to generate correspondence to**
19 **the SC regarding these actions for review, comment, and**
20 **approval at closing Plenary.**

21 This session was recessed on 17 April 2002 at 4:10 AM local time.
