1 During the period of 8-12 October 2007, 3GPP2 TSG-C meetings were held at the Renaissance
2 Long Beach in Long Beach, CA, USA. This document is intended to summarize those proceedings.

4 **OPENING PLENARY**

5 1. **CALL TO ORDER AND OPENING REMARKS:** The meeting was called to order on
6 8 October 2007 at 9:51 AM local time by TSG-C Chair, Dennis Gentzler (Alltel).

7 The Chair welcomed everyone to Long Beach, CA.

8 The Chair noted that active TSG-C member, Donghee Kim (Samsung), has undergone some
9 medical treatments and noted that he reported that his recovery is going well. The Chair
10 expressed the best wishes of the TSG and the hopes that he will return to active participation
11 soon.

12 The Chair noted the return of S. Vasudevan (Alcatel-Lucent) to active participation and
13 congratulated him on the birth of his twins.

14 The Chair advised that the objectives of this meeting included the following:

- 18 • Evaluation of the revised 3GPP2 PPA with respect to the TSG-C Terms of Reference.

20 regarding requested by the 3GPP2 Secretariat.

22 that 24 companies included on the list of 33 active quorum members were present (73%
23 participation). Thus, meeting quorum was achieved.

24 The Secretary noted that no proxy statements had been received for this meeting.

9 **and WG3 for review and action as appropriate.**

4 session, there is currently no need to schedule an interim Plenary conference call in October.

5 The Chair noted that Kim Chang, Vice Chair, with the assistance of Vice-Chair Soonyil Kwon,
6 would preside over the closing plenary session.

7 This session was recessed on 10 October 2007 at 9:05 AM local time.

- 1 • WG1 was assigned to coordinate TSG requirements for tech writer support
2 for 2008. WG2 and WG3 have reported that no support is required. WG1 is
3 requesting support for C.R1001. SWG4.2 has requested support for five
4 documents. In all, an estimated 2000 hours will be required for the tech
5 writer services for TSG-C.
- 6 • The TSG-C terms of reference were reviewed under consideration of the
7 revised partnership agreement for 3GPP2 provided in C00-20071008-016.
8 There was limited participation from other WGs. The following items were
9 recommended for review or consideration:
- 10 • The ToR begins, “The TSG cdma2000® (TSG-C)...”. The name
11 appears incomplete. It should be cdma2000 Air Interface, for
12 example to be complete. It was also discussed if the name should
13 include cdma2000 or not. It is not clear that future work will be part
14 of cdma2000 (i.e., work for IMT-Advanced).
- 15 • Section 2.3 Scopes and objectives of 3GPP2 states, 3GPP2 shall
16 prepare, approve and maintain the necessary set of Technical
17 Specifications and Technical Reports for a 3rd Generation and beyond
18 Mobile System including:
- 19 • cdma2000
20 • ...
21 • Interface of 3GPP and 3GPP2 radio access technology to
22 3GPP2 Core Network evolved from ANSI-41
- 23 • A question was raised if TSG-C is limited to cdma2000 because it is
24 specifically listed. Or should the list be considered to include but not
25 be limited by. Please note, the third bullet refers to 3GPP2 radio
26 access technology and not cdma2000.
- 27 • It was also suggested that “and beyond” be added to the following:
28 Specifically, it has a responsibility for:
- 29 requirements, functions and interface for cdma2000®
30 Infrastructure and User Terminal Equipment and beyond;
