1 During the period of 3-7 December 2007, 3GPP2 TSG-C meetings were held at the Grand Hyatt
2 Kauai in Kauai, HI, USA. This document is intended to summarize those proceedings.

4 OPENING PLENARY

5 1. CALL TO ORDER AND OPENING REMARKS: The meeting was called to order on 3
6 December 2007 at 9:20 AM local time by TSG-C Chair, Dennis Gentzler (ALLTEL).

7 The Chair welcomed everyone to Kauai and noted that Doug Dunn (Kyocera) would be
8 acting Secretary for this meeting in the absence of TSG-C Secretary, Clif Barber (KDDI).

9 The Chair advised that the objectives of this meeting included the following:

- 10 • Continue work on UMB characterization
- 11 • Resolution of Band Class V&V comments
- 12 • Begin consideration of femto cell issues
- 13 • Consideration of inputs to ITU as necessary

14 The Chair reminded the participants of the 3GPP2 social reception being held on Tuesday 4
15 December 2007 during the 6-7 PM timeframe.

16 The Chair noted that there were several FCC activities underway regarding spectrum
17 auctions with associated rules and advised meeting participants to consult with their
18 respective companies should they require addition information or guidance.

19 2. ATTENDANCE REGISTRATION AND ROLL CALL: A roll call of companies indicated
20 that 27 companies included on the list of 34 active quorum members were present (79%
21 participation). Thus, meeting quorum was achieved.

22 The Secretary noted that no proxy statements had been received for this meeting.

23 3. INTRODUCTION AND NUMBERING OF CONTRIBUTIONS: Contributions were
24 loaded onto the 3GPP2 LAN server and listed in the document register (C00-20071203-
25 000R1).

26 4. AGENDA APPROVAL: The proposed agenda (C00-20071203-001R2) was presented.

27 **DECISION: The agenda was approved without objection as modified (C00-20071203-
28 001R2).**

29 5. ASSIGNMENTS OF CONTRIBUTIONS TO AGENDA ITEMS: Contributions were
30 assigned to agenda items as noted on the agenda.

31 6. APPROVAL OF PREVIOUS MEETING SUMMARY: The summary of the TSG-C
32 meeting for November 2007 that was held in Osaka, Japan (C00-20071203-002) was
33 presented. **DECISION: This meeting summary was approved without objection as
34 submitted (C00-20071203-002).**

- 1 7. REVIEW OF OUTSTANDING ACTIONS FROM PREVIOUS MEETING: The action
2 items from the November 2007 face-to-face meeting were noted as follows:

4 (C00-20071008-135) was remanded to WG3 and WG4 for review and comment with
5 comments to be coordinated by the ITU AdHoc as an output of the January 2008

7 This action held open until closing plenary.
- 8 071105-001 WG1 was requested to investigate options to improve the communication of
9 WI status to TSG-S, even if through unofficial advance drafts, so that TSG-C status
10 can be included in the current month workplan that is regularly issued as output from
11 the TSG-S meeting.
12 This action was held open until closing Plenary.
- 13 071105-002 WG2 was requested to review current HRPD document structure issues to
14 confirm that this structure if optimized for handling the interworking functions.
15 This action was held open until closing Plenary.
- 16 071105-003 TSG-C WG Chairs and Vice-Chairs were requested to review all document
17 structure issues and be prepared to discuss these issues on a future TSG-C
18 Leadership conference call.
19 This action was held open until closing Plenary. This issue will be addressed at
20 chairs meeting on Wednesday.
- 21 071105-004 At the request of QUALCOMM, the WG2 Chair took an action to
22 coordinated HDP work with the WG 3 Chair and to bring a proposed plan of action
23 to opening plenary in December 2007.
24 This action was held open until closing Plenary.
- 25 071105-005 The Chair reiterated his call for contributions and manpower support UMB
26 MPS development activities in an effort to meeting the proposed March 2008
27 schedule for UMB MPS baseline text.
28 This action is ongoing and will not be repeated as an OPEN action item.
- 29 071105-006 The Chair took an action to forward the updated TSG-C ToR to the SC for
30 approval.
31 The Chair advised the participants that he had presented TSG-C ToR to the SC and
32 questions were raised resulting in review of all ToRs at a joint session in December.
33 The Chair noted that the removal of “video” from codec section was the area of
34 concern. **DECISION: This action was CLOSED without objection.**

18 will be held from 12:00-1:00 PM on Tuesday to discuss and resolve any
19 outstanding issues.
- 20 It was further noted that, once the TSG review/PMT coordination session are
21 concluded, the terms of reference will be presented to the Steering
22 Committee for review and approval via email and will not necessarily wait
23 until the February meeting. if the review activity is concluded before that
24 time.
- 25 Lastly, it was noted that action item 2007/11-04 does not preclude the TSGs
26 from addressing any work on activities that fall into the category of “beyond
27 3G” while this review is taking place.
