During the period of 2/14-18/00, 3GPP2 TSG-C meetings were held at the U.S. Grant Hotel in San Diego, CA. This document is intended to summarize the proceedings.

OPENING PLENARY

The meeting was called to order at 11:35 AM local time on 2/14/00 by TSG-C Chair, Jean Alphonse (GTE Wireless).

- The roll call of companies indicated that 36 companies already included on the list of 45 active members were present and thus quorum was established (80% participation).
- The proposed agenda (3GPP2-C00-20000214-001) was presented and approved without objection as submitted.
- Contributions were numbered, distributed, and assigned to agenda items. The Secretary also noted contributions from the 1/28/00 3GPP2 SC meeting (the SC document number was retained).
- The meeting summary from the 1/00 meeting in Vancouver, BC (3GPP2-C00-20000214002) was presented and approved without objection.
- The meeting summary from the 2/1/00 conference call (3GPP2-C00-20000214-003) was approved without objection as submitted.

 - WG1 REPORT (3GPP2-C00-20000214-101) was presented by the WG1 Vice Chair, Mitch Tseng (Nokia), as FYI.
 - Reviewed draft text for C.P1001-A (parameter value assignments). All priority number assignment requests which have been received to date have been incorporated and document reference numbers will be converted by the 3/00 Cheju, Korea meeting.
 - Met with TSG-S WG1 to review video services Stage 1 issues.
 - Met with TSG-S PMT to review Release B workplan issues including ways to improve coordination of feature details between TSGs.
 - WG2 REPORT (3GPP2-C00-20000214-102) was presented by WG2 Chair, Kim Chang (Nortel Networks), as FYI:
 - WG2 and its SWGs spent most of the time resolving ballot comments for the MAC, LAC, Layer 3, and analog documents.
 - These groups will meet during the interim meeting at TIA headquarters during 3/14/18/00.
 - WG3 REPORT (3GPP2-C00-20000214-103) was presented by WG3 Chair, Ed Tiedemann (QUALCOMM):
 - Review of Walsh code assignments, R-RAKE, and inter-generational handoff is in process.
 - Reviewed ballot comments for Release A physical layer document. The remaining comments are intended to be resolved during conference calls prior to the interim meeting.
 - Incorporated band class 7 for the recently allocated 700 MHz spectrum.

- WG4 REPORT (3GPP2-C00-20000214-104) - no report
- NEW BUSINESS
 - The cdma2000 reference document guidelines, v2 (3GPP2-C00- 20000214- 105) were presented. This contribution presented a strategy for document references which would make the 3GPP2 documents usable directly (i.e., pdf file) without modification by all SDOs. The document references would specify a document reference number which is an index to a cross reference table which will specify the 3GPP2 number as well as any and all of the equivalent SDO document numbers. For IS-2000 documents, the cross reference table for all volumes will be included in the introduction volume (i.e., C.S0001-A/IS-2000.1-A). This proposal was adopted without objection.
