ABSTRACT: This document is a summary of the 3GPP2 TSG-S meeting that was held during the period 10-13 June 2002 in Shenzhen, China.

During the period of 10-13 June 2002, 3GPP2 TSG-S meetings were held at the Wuzhou Guest House Hotel in Shenzhen, China. This document is intended to summarize those proceedings.
