During the period of 26-30 August 2002, 3GPP2 TSG-S meetings were held at the Regal International East Asia Hotel in Shanghai, China. This document is intended to summarize those proceedings.

OPENING PLENARY

1. **CALL TO ORDER AND OPENING REMARKS:** The meeting was called to order on 26 August 2002 at 8:30 AM local time by TSG-S Chair, Rich Robinson (Sprint PCS).

The Chair welcomed everyone to Shanghai, China. The meeting attendees introduced themselves and their affiliation.
2. **ATTENDANCE REGISTRATION AND ROLL CALL:** A roll call of TSG-S active companies indicated 18 companies in attendance out of 23 active companies (78% participation). Thus, meeting quorum was achieved. Sign-in of individual attendees was accomplished via a sign-in sheet.
3. **DISTRIBUTION AND NUMBERING OF CONTRIBUTIONS:** Contributions were documented in S00-20020826-000. All contributions were distributed as soft copy only and were made available from the server.
4. **ADOPTION OF AGENDA:** The proposed agenda (S00-20020826-001) was presented.

 - The use of teleconferences and face-to-face meetings to facilitate cross-TSG review of Stage 1 documents in development is strongly encouraged. However, final review of Stage 1s using these mechanisms will be strongly discouraged except in exceptional cases as approved by the TSG-S Plenary.

- Flexible and practical mechanisms will be employed for interim cross-TSG reviews to maximize the efficiency and effectiveness of those meetings.
 - Cross-TSG conferences, whether face-to-face or via teleconference, will be requested by the editors of the Stage 1 documents, and scheduled by the WG1 chair, in coordination with the Chairs of the TSGs.
- Work will progress with the best effort to send out draft Stage 1 documents and resolve all comments within a 4-meeting cycle, as shown in document S.P0070.
 - TSGs will always be requested to respond within the timeframe and their acceptance of the requirements will be assumed unless they notify TSG-S to the contrary by the requested date.
- The TSG-S correspondence requesting Stage 1 review will also include the relative priority of Stage 1s by indicating whether the associated work item is scheduled for the upcoming release, or subsequent releases, based upon the current workplan.

ACTION: The Secretary was directed to review all previously approved outbound WG1 correspondence to make sure that all requests for responses to Stage 1 reviews are specified for 28 October 2002.

ACTION: The WG3 Report (S00-20020826-103R2) was remanded to WG1 to incorporate the documented strategies into their working procedures.
