1 During the period 3-6 December 2007, 3GPP2 TSG-S meetings were held at the Grand Hyatt Kauai
2 in Kauai, HI, USA. This document is intended to summarize those proceedings.

4 **OPENING PLENARY**

5 1. **CALL TO ORDER AND OPENING REMARKS:** The meeting was called to order on
6 3 December 2007 at 1:25 PM local time by TSG-S Chair, Nick Yamasaki (KDDI).

7 The Chair welcomed the participants to Kauai.

8 The meeting participants were requested to sign-in electronically using the server sign-in
9 facility.

10 The Chair announced that Eileen McGrath (NEC) would be acting as the Scribe for this
11 meeting in the absence of TSG-S Secretary, Clif Barber (KDDI), and he thanked her for her
12 support in this effort.

13 The Chair reminded the participants of the 3GPP2 social reception being held on Tuesday
14 4 December 2007 during the 6-7 PM timeframe.

15 The Chair noted that Randy Scheer (Alcatel-Lucent) is no longer working in 3GPP2 and,
16 more specifically, TSG-S WG5. Since WG5 had only two (2) primary participants, the
17 future of WG5 must be evaluated in light of Randy's resignation. This topic will be
18 discussed on a conference call on Tuesday 4 December 2007 during the 9-11 AM period HI
19 time. Call in information was noted as follows: **+1-800-771-8734 (or outside the U.S.: +1-**
20 **647-723-3053) - access number #9790615.** All persons interested in the future of WG5
21 were requested to participate in that call. It was noted that Alcatel-Lucent has not yet named
22 a replacement.

24 that 14 companies included on the list of 20 active quorum members were present (70%
25 participation). Thus, meeting quorum was achieved.

26 The Secretary noted that no proxy statements had been received for this meeting.

4 standards related, involved parties are encouraged to bring them to the
5 attention of TSG-S so that we can expedite any actions as appropriate.
