1 During the period of 12-15 May 2008, 3GPP2 TSG-C meetings were held at the Hotel New Otani Osaka
2 in Osaka, Japan. This document is intended to summarize those proceedings.

4 **OPENING PLENARY**

6 2008 at 1:07 PM local time by TSG-S Chair, Nick Yamasaki (KDDI).
