1 During the period of 25-28 January 2010, 3GPP2 TSG-S meetings were held at the Grand Hyatt Erawan,
2 Bangkok in Bangkok, Thailand. This document is intended to summarize those proceedings.

4 OPENING PLENARY

6 Monday 25 January 2010 at 1:41 PM local time by TSG-S Chair, Nick Yamasaki (KDDI).

7 The Chair welcomed everyone to Bangkok and asked that everyone introduce themselves.

8 The meeting participants were requested to sign-in electronically using the server sign-in facility.

9 The Secretary updated the membership on the status of the family of former TSG-C/TR45.5
10 Chair, Jean Alphonse, as a result of the recent earthquakes in Haiti.

12 lower level.
