1 During the period of 28-31 March 2011, 3GPP2 TSG-C meetings were held at the Grand Hyatt Seoul

4 **OPENING PLENARY**

6 Monday 28 March 2011 at 1:45 PM local time by TSG-S Chair, Nick Yamasaki (KDDI).

7 The Chair expressed his gratitude to everyone who expressed their concern for the Japanese
8 participants of 3GPP2 in light of the severe disaster in that country. He led TSG-S in a moment
9 of silence.

10 The Chair welcomed everyone to Seoul.
